Pathways & Programs: Lessons Learned from Three LEAD Programs at Different Stages of Growth

Speakers: Adam Vose-O'Neal, Brandeis University; Marie Kerrin, NAMI New Orleans; Hailey Richards, Washtenaw County Sheriff's Office

In this moderated panel, deflection practitioners will share lessons learned from three LEAD sites at different levels of development. This moderated panel will provide first-hand perspectives from LEAD program managers in Washtenaw County, Michigan, and New Orleans, a police sergeant from Albany, New York, and a LEAD evaluator also from Albany. Washtenaw County's program is under two years old, LEAD New Orleans is recovering and growing after a defunct phase, and LEAD Albany is the third oldest program in the country. Panelists will compare and contrast the differences in program approaches and policies, including referral streams and collaboration efforts across silos.

Many community and policy stakeholders have begun considering alternative policing models, such as LEAD, that shift away from a dependence on arrest and incarceration towards an evidence-based public health and racial equity approach. Understanding facilitators and barriers to success as experienced by policymakers, police officers, and program participants can help jurisdiction's better structure and implement LEAD and other deflection programs.

Denver has implemented several evidence-based or evidence-informed early intervention police-civilian partnership initiatives in the past 7+ years that support concepts of deflection and pre-arrest diversion.

This workshop will provide an overview of Denver early intervention response initiatives including the Co-Responder program; the Substance Use Navigator (SUN); the Law Enforcement Assisted Diversion (LEAD) program; the Early-Intervention Team (EIT); the Support Team Assisted Response (STAR); Outreach Care Coordinators; and the Assessment, Intake and Diversion (AID) Center.

Creating a Culturally Responsive Organization: Diversity Equity, Inclusion and Belonging

This workshop will promote health equity by encouraging participants to co-create more inclusive environments by addressing how social injustice and disparity of care has impacted historically underrepresented communities. Diverse Partners, Common Goal: Public Health and Public Safety Success Story of Partnerships, Best Practices, and Reducing Overdoses

Understanding the evolving nature of the overdose epidemic is a significant challenge for public health and public safety. Multi-sector collaboration offers the opportunity to work across silos and is proposed as a best practice to mitigate community drug harm. Although some jurisdictions have strong collaboration, many can benefit by further exploring how to share expertise and maximize impact. This session provides an overview of the partnership between the New Jersey State Police (NJSP), the Ocean County Health Department (OCHD), and the Overdose Response Strategy (ORS) to share best practices and reduce overdoses, integrating strategies.

This session features multi-sector and multi-level panelists describing the integration of cross-sector collaboration strategies through NJ's partnership around referral, deflection, and proactive outreach. Such approaches can contribute to community context and situational awareness, systems-level thinking, and information sharing across a network to reduce the overdose epidemic.

Pathways & Programs: Juvenile Deflection and Pre-Arrest Initiatives: Reducing Arrests, Building Community

In this session, a panel of juvenile deflection and youth services experts will provide an overall understanding of the burgeoning field of juvenile deflection programs with special emphasis on juvenile civil citation programs and supportive and wraparound services. Panel members will describe the five main components of a successful program and provide a list of benefits of juvenile deflection. They will also highlight the resources gained from the collaboration of community partners needed for developing and operating such a program.

Panel members represent a wide range of experience in youth services, the justice system, the behavioral health system, and child welfare, which is representative of the model. Much of the information provided is also applicable to adult programs. We encourage anyone who is considering developing and implementing a juvenile civil citation or deflection program, or who might want to expand this initiative to their adult program, as well as anyone interested in learning about juvenile deflection, to attend this important presentation.

Colorado Spotlight: Tensions between the Mental Health and Criminal Justice Systems

The Office of Civil and Forensic Mental Health (OCFMH) operates at the intersection of the mental health and criminal justice systems by providing a continuum of mental health care that includes pre-trial competency restoration services, inpatient hospitalization and soon, transition homes for community-based care. One of the office's biggest challenges is the waitlist for inpatient competency restoration services, which has exploded in the wake of the pandemic.

This transparent and honest presentation will outline the problem the state is facing in a way everyone can understand. It will also outline solutions and new initiatives the office is working on to help Coloradans get the services they need in a timely manner. The session will invite collaboration between the audience and challenge everyone to consider how they can be part of the solution.

Research and Evaluation: How to Do It Right and Why You Should

This moderated panel features collaborators in this effort from Hamilton County, OH — home of the nation's first Quick Response Team. The panel will discuss the importance of (a) strong researcher-practitioner partnerships and how to develop and maintain them, (b) systematic data collection and data management, (c) expanding the scope of evaluation and research beyond funding performance measures, and (d) pushing the envelope to standardize language, measurement, and outcomes in deflection research. The presenters will offer some concrete strategies for attendees that are grounded in their own experiences from several evaluation projects within the State of Ohio (and beyond) and best practices in program evaluation and implementation.

The Future of Law Enforcement and Public Health Interventions

There appears to be a shifting away from police officers acting as agents of social outreach in favor of a reliance on trained social work or human service professionals. Other communities are now opting for non-police or community response methods. Why is this the case? To answer this question, this session will look at three policy frames for implementing law enforcement and public health (LEPH) interventions, each representing a distinct historical period of reform; community policing, police-based Crisis Intervention Teams, and co-response models.

Although we have come a long way in how the police handle encounters with vulnerable populations, we have also moved away from the officer as outreach-catalyst or trained interventionist roles. Police remain the round-the-clock default service provider in many communities. The future of LEPH approaches may depend on the willingness of the police to embrace a broader social service role.

Pathways & Programs: The Community Responder Model: How a Civilian First Response Can Improve Outcomes for Officers

Today, law enforcement is expected to respond to the vast majority of 911 calls, including low priority non-violent issues, putting a significant strain on individual officers and agency-wide resources. This session will explore how localities are reducing the burden on law enforcement by establishing a new branch of civilian first responders that can be safely dispatched in response to specific types of 911 calls related to non-criminal, non-violent issues in the community. Local police leaders will share their own experiences with civilian first responders, providing an overview of how these models are improving outcomes for their officers and the communities they serve.

Coloring Inside the Lines: How to Run an Effective and Ethical Diversion Program

Topics will include choosing and vetting good partners, the Eliminating Kickbacks in Recovery Act, support for police and recovery coaches operating the program, oversight, transparency and accountability.

From Chief to Officer: Practical Strategies from the Field, Creating Organizational Culture to Obtain First Responder Buy-in

In July 2018, the Tucson Police Department (TPD) implemented a comprehensive deflection program to address, in an innovative but meaningful way, substance misuse while minimizing recognized collateral problems created by the traditional police approach of arrest and incarceration. A significant hurdle to overcome was achieving investment and buy-in from the officers who were given the discretion to arrest or deflect.

A moderated panel will discuss the effectiveness of, and lessons learned from implementing the TPD Deflection Program. The panel will discuss organizational culture in policing, approaches to change, and practical strategies from the perspectives of a leader in a police department and an officer who has embraced deflection. They will also discuss program successes, strengths, challenges, and lessons learned in implementing and sustaining the program in a major city police department.

Using Data to BRIDGE Communities, Law Enforcement and Public Health

In this session, Aimee Shadwick will discuss how RecoveryOhio partners with communities across the state to reduce overdose deaths and other consequences of the opioid epidemic. Aimee will explain how Ohio is combining data from various departments and sources to create a publicly available data dashboard.

Richard Meadows will discuss Operation BRIDGE (Bridging Recovery and Interdiction Data Gathering Enforcement), a research-based initiative that compliments Ohio's deflection efforts by providing enhanced support to communities and individuals most at risk of overdose. The panelists will reflect on the barriers and facilitators to this kind of collaboration, and discuss how deflection initiatives can partner with state departments to have broader, more equitable impact.

Pathways & Programs: Solutions from D.A.R.T. – The Nation's First Naloxone-Plus Deflection Pathway Program

This moderated presentation will outline the successes and challenges faced by the Lucas County Sheriff's Office (Toledo, OH) D.A.R.T unit as they implemented the Naloxone-Plus Pathway and Active Outreach Pathway toward deflection. The panel will discuss guidelines to the successful implementation of their strategies for linking individuals to treatment, the development of better relationships between law enforcement and the community, as well as enhanced collaborative relationships between community stakeholders which have maximized their community impact.

The panel will highlight collaboration across silos, multipathway approaches, and shared learning. They will offer a unique way of doing deflection to serve people and offer practical solutions and tangible ideas for deflection practitioners. Participants will walk away with a better understanding of the development of a Naloxone-Plus and Active Outreach Deflection Pathway as they prepare to evaluate their community's needs and community stakeholders. Participants will also be provided with resources to better complete a comparison analysis of the best model for their community.

Making Data Matter: Prioritizing Data Collection as a Strategy to Build Community Capacity

Community collaborations often have a hard time getting off the ground and an even harder time sustaining their efforts. Experience indicates data can be an anchor point of effective community collaborations. Effective data collection permits the development of standardized languages for describing problems, tracking trends, and documenting critical outcomes. Data also facilitates asking the right questions that promote program enhancement. The presenters will demonstrate how early commitments in data collection were critical to the implementation and expansion of local efforts to address the opioid overdose crisis.

Shifting the Paradigm: Key Elements for Trauma-Informed Care

Pathways & Programs: FAN REDIRECT Program: Changing Lives, Perceptions and Communities

Law enforcement, prosecutors, social service providers, and other community stakeholders should work together to more effectively meet the needs of substance users through community-based, harm reduction-framed care.

Families Against Narcotics' REDIRECT pre-arrest deflection program offers a robust and effective alternative to prosecution and incarceration for individuals who have committed low-level, drug-related offenses. REDIRECT Case Managers provide intensive, one-on-one, substance use-focused case management services to substance users, supporting them and helping them address specific needs, achieve stated goals, improve their quality of life, and increase their self-sufficiency. As a result, crime and recidivism are reduced, the community becomes safer, relationships between law enforcement and the general public improve, and the stigma surrounding addiction is reduced. Two members of the REDIRECT team will explain how the program came to be, how it works, and why it's so important in today's world.

International: Where are the Police? Policing and Harm Reduction - the Right Intervention at the Right Time

The intersection of policing and public health is crucial to support people away from the criminal justice system, subsequently reducing harm, reducing crime and reducing cost to society. Drawing on the expertise of developing and delivering services and interventions in the UK, Cranstoun asks 'where are the police' in harm reduction and present what good looks like when working with the police and partners to support people with the right intervention at the right time.

Within the confines of the current legal framework, Cranstoun have sought to deliver a public health and compassionate approach to people who come into contact with the criminal justice system. Cranstoun presents a whole system approach that can be used by any police force, anywhere in the world to provide the right intervention at the right time. The session will focus on practical examples of challenges, learning and show how our services continually evolve based on the experiences of those we support.

Just Like Dating: Moving from the Theory of Collaboration into Action

"The opposite of addiction is community," Johann Hari's brilliant theory has been backed by multiple studies indicating the healing power of interpersonal connection. While this principle was initially used to treat addiction, it is also applicable to understanding the needs of our communities. Creating connections and relationships can be difficult due to fear of rejection, judgment, and stigma to name a few barriers. In this session, we will provide actionable steps to break down the theory of collaboration into practical application, using the elements of the Strategic Prevention Framework: Assessment, Capacity, Planning, Implementation, and Evaluation and how each relates to a contextual approach. Using the metaphor of dating will help associate the concepts on how to move from wishful thinking to the excitement of a fulfilling relationship. Our goal is to help participants leave the summit with a clear plan of how to maximize relational collaboration when accomplishing your goals in whatever area you aim to create change.

Pathways & Programs: Combating Fatal Overdoses: A Data-Driven and Multidisciplinary Approach to All Six Deflection Pathways

The Office of Addiction Response combats overdoses and overdose deaths by utilizing cross-sector planning and collaboration. In October 2022, Hamilton County was awarded a COSSUP to launch a first-of-its-kind pilot to involve all six deflection pathways as a referral source to a single, co-responder program. Hamilton County's Co-Responder Deflection Pilot (HC CORE) is a collaborative, co-responder intervention to assist individuals with substance use disorders, mental health disorders, or homelessness.

In this session, presenters will highlight the innovative method to identify and catalog services in target areas and how to create a coordinated pathway to care by sharing and maximizing outreach data. They will also discuss the development of the HC CORE initiative, methods of data collection, sharing mechanisms, and the key metrics of success for their work.

Identifying Initial Ingredients: Making a Prosecutor Led Deflection Program from Scratch

This workshop, open to all participants, will cover how to build a deflection program for a semi-rural community. Speakers will present the Pathways Program and cover seven key components to help attendees establish or enhance their own deflection program.

The speakers will also identify some of the common challenges that these programs experience, and how they have addressed them in a practical way. Like most good recipes, there is no strict set of ingredients. Each community is unique in its needs and resources. Therefore, each recipe will need to be tweaked to fit the community.

Language Matters: Combatting SUD and MHD Stigma Together

Illicit substance use disorder is the most stigmatized health condition in the world, with alcohol use disorder and mental health disorders not far behind. Stigma contributes to social isolation, reduced or delayed care access and treatment adherence, poor quality of life, and even loss of life itself. Using language that stigmatizes, shames, and rejects people with addiction or mental health disorders contributes to the vicious cycle that entrenches their conditions.

This session will provide participants with alternatives to stigmatizing terms and labels and will provide practical, respectful, and non-judgmental, communication strategies and person-first language. By reducing stigma, we can shift the narrative and promote policies and practices that can contribute to better outcomes for a population that deserves nothing less. Let's replace judgment with understanding, stigma with empathy, and shame with hope!

Diverse Options: Voice & Empowerment (DOVE) Delegates is a newly developed project that seeks to reduce judicial involvement of our most vulnerable community members in Louisville, KY. DOVE Delegates and the community will co-create and implement a re-imagined community safety plan. The overall vision of DOVE Delegates is to reduce the rate of interaction with Louisville Metro Police Department that may lead to incarceration/ hospitalization of those with mental health issues and other marginalized community members; expand the capacity of Black and brown clinicians to work within their communities; and support community in building informal leadership, community connection, and skills that enhance community safety.

Through our presentation, we will share the process of developing the project, what we are learning along the way, and outcomes as a result. DOVE's approach centers the community, specifically those with lived experience, brings to them to the decision-making table, and taps into their expertise on how to best serve them.

Veterans Deflection Pt 1: Something New for Our Field and from Our Field

The Solutions Action Plan (SAP) is a tool developed by TASC's Center for Health and Justice and PTACC's National Leadership Council (NLC) to help sites develop or enhance deflection strategies that will be ready to implement immediately upon return to their communities.

The tool is a real plan, not just an exercise. Planning will start with the team clearly stating the problem to be addressed and determining the desired outcome by defining what success looks like and the "why." The plan will then guide the team through steps including identifying system partners, action steps, and how the initiative will be evaluated and sustained. Each site will have one-on-one guided facilitation and access to subject matter experts (SME) who will help them through the process as they follow the tool and develop their deflection SAP.

All sites that pre-registered for Technical Assistance (TA) Action Planning through the pre-event survey will begin their action planning together with an orientation and then follow their assigned facilitators to their breakout rooms to start real-time, hands-on TA focused on planning, implementing, and/or enhancing deflection programs in their communities.

On Friday morning, teams will report out about the deflection initiative they developed, how it will address the needs of their community, and how they will achieve the goals they set for their program.

Transit Tuesdays: A Collaborative Response to Low-Level Crime in a Major Transit Hub (Workshop)

As a result of the pandemic, social workers at Newark Community Solutions brought community providers, court personnel, and law enforcement together to develop a system that would more effectively respond to the legal and social needs of unsheltered individuals at the city's major transit hub. Employing a systems theory approach to criminal activity at Newark Penn Station, this multi-agency collaboration sought to provide interventions at the individual and systems level by offering wrap-around social services in lieu of or alongside arrest, altering how the legal system processed these criminal cases.

This presentation will chronicle the development and implementation of this collaboration, using case studies to illustrate how it works in practice. Together, Newark Community Solutions and the NJ Transit Police Department will share how they communicate to problem-solve and respond to community needs. From the social work perspective, Newark Community Solutions will highlight how the partnership developed, a profile of participant needs, and the services provided by both the agency and community partners. The NJ Transit Police Department will share their experiences within the legal system including the issues officers face policing a major transit hub and how this initiative enhanced their work.

Veterans Deflection Pt 2: Connecting with Your VA Partners

Building on the morning plenary, the afternoon panel will dig deep into operating partnerships between local law enforcement led deflection efforts and VA partners. The panel will include several Veterans Justice Outreach Specialists from across the country, working both with Veteran-specific deflection initiatives and a deflection program serving the broader population. Panelists will provide specific strategies for identifying veterans in the populations they serve, describe specific steps to connect with local Veterans Justice Outreach Specialists at each VA Medical Center in the country, and hear first-hand about the wide array of services to which eligible veterans can be connected through a warm-handoff from the community to VA. The panel will also highlight research evidence, existing community-deflection programs, and organizational culture implications for collaborations between behavioral health and law enforcement partners.

The Impact of Deflection (Workshop)

This presentation will report findings from a 2023 National Institute of Justice-funded process evaluation conducted by the RAND Corporation, Illinois Criminal Justice Information Authority, and TASC Center for Health and Justice. The study of six deflection initiatives involved in the self-referral pathways and outcomes evaluation of two of these sites add to the growing evidence of deflection’s impact, including findings linking deflection to the reduction of overdose deaths and property crimes.

The presenters will speak to the study methodology and multiple areas the study and its researchers probed: the quantitative data aligning deflection with these outcomes; the internal policies employed by deflection initiatives in establishing their formal operations; how the way these initiatives carry out deflection speaks to the larger practice of deflection; and a “discourse of deflection” emerging in the field.
